

# 2011 FALL PRODUCT PROGRAM TRAINING SCHEDULE

To provide troops with the materials, information and support they need to help girls be successful, the Fall Product Manager (FPM) for every troop participating in the 2011 Fall Product Program must attend a 2011 FPM training session. ALL program materials are distributed at the training sessions.

*First time FPMs* should attend a **NEW** Fall Product Manager training session which will last approximately 1-1/2\* hours. These sessions cover all aspects of the program and the Nut-E 2.0 data entry system.

*Returning FPMs* may attend an **Experience (EXP)** Fall Product Manager training session, which will last approximately 1/2\* hour. These sessions cover only the program updates and the Nut-E 2.0 data entry system.

**NOTE:** The sessions in **Blair** and **Fremont** will be a combination of New and Experienced materials depending on the experience of the FPMs in attendance. These sessions will last approximately an hour.

\*All session times are approximate depending on the number of attendees and questions. Please arrive a few minutes early to allow for check-in and material pick-up, and plan to stay for the *entire* session.
